# Licensure vs. Certification: What Would we Lose?

Recently the Montana state licensing board sent out a survey regarding the licensing process in the state of Montana. This not only affects Clinical Laboratory Science but it affects all licensed healthcare professions. Below I've outlined the scope of ASCP certification and the scope for the Montana licensing board. As highlighted in yellow the two roles are vastly different.

ASCP focuses on your qualifications and competence. State licensing is a safety measure ensuring there are no complaints against you, or misconduct filed. A national certification board will never be monitoring the safety of our profession to that level. The role of the state is to maintain the safety and care of our patients and profession in our healthcare facilities.

Please take this information and share with other licensed professionals. Write to the board of licensing to question the prospected role changes are not just a financial decision.

#### ASCP Certification

Certification and Credential Maintenance Certification is the process by which a nongovernmental agency or association grants recognition of competence to an individual who has met certain predetermined qualifications, as specified by the agency or association. The ASCP Board of Certification (BOC) provides a mechanism for these individuals to be recognized as having the necessary competence to perform the medical laboratory roles they seek. This mechanism is called certification. ASCP BOC certification is time-limited for three years. To remain valid, certification must be maintained by completing the Credential Maintenance Program (CMP) as described on page 36.

- 9. Promote online application and renewal processes to achieve efficiencies and enhanced delivery of services.






