## Montana Laboratory News





#### JAM Notes/Recap from Holly Weinberg

The ASCLS Joint Annual Meeting (JAM) was another great experience, and the Montana delegation did an excellent job representing our state. The annual Board of Directors meeting was very long but it provided for in-depth discussion of several topics. The newer format for BOD meetings begins with strategic discussions of up to 3 topics; at this meeting the topics covered 1) a fresh look at our Mission, Vision, and Values, 2)how to measure diversity in our organization, and 3) making accommodations for disabilities and providing a standard for inclusion. The third topic stemmed from a constituent society's concern when planning their spring conference and receiving a request for special accommodations for a hearing-impaired Developing Professional member. In this case, the availability of closed captioning on the zoom site was not adequate as this individual grew up using ASL (American Sign Language) and the closed captioning was like a foreign language to her. I admit this is something that never crossed my mind, always assuming closed captioning was an excellent alternative for the hearing-impaired. The cost of hiring a sign language interpreter is very steep so what accommodations do we have as an organization to address this? Food for thought.

During the week, we attended governance meetings, educational sessions, and networking events while still getting a chance to visit Pittsburgh. We attended the Region VIII Council meeting at the beginning of the week and saw our 2 interns, Grei Sebastian, MT and Jin Heo, UT present an outstanding project promoting the profession of Medical Laboratory Science, followed by graduation. We also convened with the rest of Region VIII attendees for the annual regional dinner after the awards ceremony on Wednesday evening. Montana once again brought home numerous awards -way to go!

As the Elections Chair for this year's meeting, I had a few extra things going on. The election opened on Tuesday morning after the presentation of the candidates. We ran into a situation that we've never dealt with before; we've had tie votes but nothing to this extent. This year we had 2 nominees for President-Elect, and 9 nominees for 5 open Director at Large positions. After the first ballot, the PE race was tied and 4 Director nominees received 50% of the vote, meaning we needed to do a run-off for both PE to resolve the tie and Director to determine the 5 th nominee. We understood that all positions required a majority (>50%) to win, so in the Director race, our SOP states that the lowest vote getter drops off the runoff ballot and the remaining nominees appear on the ballot. The first runoff ballot took place Tuesday evening and President-Elect was decided in Kyle Riding's favor; however, the Director ballot still didn't get a majority so another runoff took place Wednesday morning dropping the lowest vote getter and the remaining 3 nominees were on the ballot. That ballot still didn't produce a majority so yet another ballot now with 2 nominees and we finally had a winner! After the meeting concluded, ASCLS President Pat Tille with approval of the BOD, appointed an Elections/Credentialing Task force to look at the process from Credentialing through Elections and develop a detailed SOP to better define our process. One of the biggest issues is our old documents are all based on past years when the process was entirely manual; we are now attempting to update to hybrid in-person/virtual attendee voting. I want to thank the Montana members for allowing me the opportunity to represent you at the annual House of Delegates, this is an honor that I don't take lightly! The Montana Delegation was an example to all, attending and actively participating in governance activities throughout the week, and bringing home exciting ideas to make our Montana Society even better.





#### ASCLS Labvocate (formerly Legislative Symposium): Fall Preview

Every year, ASCLS constituent society members collaborate with partner organizations such as ASCP, AGT, AMT, NSH, and PAMET-USA to address regulatory and compliance issues in the industry. Additionally, they dedicate a day to meeting with U.S. congressional representatives and senators on Capitol Hill to discuss critical issues and concerns affecting the laboratory profession. This united effort demonstrates the significant impact that a cohesive front can have in driving change.

This year, Montana will be represented by Anne Tate, ASCLS President Elect at the Labvocate Symposium September 30-October 1, 2024. Plans are in place for meetings with Senators Jon Tester and Steve Daines, as well as House Representative Ryan Zinke. Key topics for discussion with our State Senators and Representatives include addressing laboratory workforce shortages, proposed funding through Title VII, and the status of the SALSA Act, which is intended to replace the PAMA Act and prevent reductions in the laboratory fee schedule to unsustainable levels.

#### **Laboratory Staff Shortages**

The laboratory profession has long struggled with a shortage of qualified personnel, a challenge that has persisted for over twenty years. Despite the CDC estimating over 14 billion tests are conducted annually—a number that continues to rise—the workforce is dwindling. Baby boomers are retiring at a rate that outpaces the replacement of new laboratory scientists, and the current number of training programs is inadequate to meet the increasing demand. ASCLS advocates for expanding Title VII Authorization to include laboratory science professionals. Such an expansion of the Title VII would provide essential funding for MLS and MLT scholarships, grants, and growth of both existing and new training programs.



#### PAMA vs SALSA Acts – Drastic Reduction in the Lab Fee Schedule

Attention laboratorians! It's crucial to be informed about the PAMA Act. Enacted in 2016, the Protecting Access to Medicare Act of 2014 (PAMA) mandated significant cuts to the Laboratory Fee Schedule. Lab Fee schedule cuts impact ALL laboratories! These fee schedule reductions are severe and not reflective of market data from all types and sizes of laboratories. Since 2016, there has been one round of cuts, with further reductions postponed by Congress. It is expected that the 2023-2024 Congress will defer additional cuts to the fee schedule until 2025.

The Saving Access to Laboratory Services Act (SALSA), introduced in Congress in 2021, aims to address the flaws in PAMA by improving market data collection. Including data from all laboratory types and sizes will help establish more sustainable market rates for laboratory testing.

Support ACLS and ASCLS by joining the <u>Stopthecuts</u> campaign, which advocates for the adoption of SALSA to ensure patients continue to have access to affordable laboratory testing.
